### PART I

Whereas the MODEL has voluntarily elected to undergo skin treatments and procedures provided after the nature and purpose of the treatment has been explained by the ESTHETICIAN.

Some of the treatments, products, modalities, used to perform the skin treatments and home-care may be provided at no cost to the MODEL in trade for granting permission to the ESTHETICIAN to use the treatment results as further described in Part II below.

Although it is impossible to list every potential risk and complication, MODEL has been informed of possible benefits, risks, and complications and acknowledges there are no guaranteed results and that independent results are dependent upon age, skin condition, and lifestyle and that there is the possibility further treatments of the treated areas to obtain the expected results may be necessary at additional costs.

The MODEL has provided the ESTHETICIAN with an accurate medical history and does not hold the ESTHETICIAN responsible for any conditions that were present, but not disclosed at the time of this skin care procedure, which may be affected by the treatment performed.

The MODEL acknowledges the required post-treatment home care instructions and understands how important it is to follow all instructions given for post-treatment

care. The MODEL agrees to perform all post-treatment home care as prescribed by the ESTHETICIAN. **Failure of MODEL to conduct all prescribed post-treatment home care is a breach of this agreement and the MODEL will immediately be required to pay the ESTHETICIAN full price for of all services and products received and used.**

Whereas for valuable consideration, hereby acknowledged as received, the MODEL grants the ESTHETICIAN permission to photograph and/or film and sound record, and use video diaries and other related media of MODEL and furthermore grants permission to use the resulting work ("THE WORK") according to the terms stated hereunder:

1. Any permission granted to the ESTHETICIAN shall extend to her successors, legal representatives, licensees and assigns and shall be irrevocable and perpetual without any further or additional claim for compensation by the MODEL.
2. Use of THE WORK shall be unrestricted as to location, quantity or frequency, may be for any purpose and in any medium whatsoever, whether foreseen or unforeseen at this time, except where such use is in contravention of the law.
3. Permission is specifically granted for THE WORK to be edited, altered, distorted, used in whole or in part, in conjunction with other images, graphics, text and sound in any way whatsoever and without restrictions.
4. Permission herein granted is absolute and final and shall not be subject to further inspection or approval by the MODEL at any stage in the use of the Work.
5. Use of the Work may be in conjunction with the MODEL's own or fictitious names.

6. The ESTHETICIAN shall own all rights in the Work which shall accrue to the benefit of his/her successors, legal representatives and assigns.

7. The MODEL warrants having read and understood this Model Release Agreement and warrants being of full legal age to enter into an agreement.

8. With full knowledge of the above, the MODEL hereby releases and shall hold harmless the ESTHETICIAN and her successors, legal representatives, licensees and assigns from all claims or damages including but not limited to defamation or violation of right of privacy or publicity, resulting from or associated with the use of the Work.

9. The MODEL agrees that the provisions contained herein shall be binding upon the MODEL and his/her successors, legal representatives and assigns.
